

- ▶ For 25 years now, VIM has provided care for the medically underserved living or working on Hilton Head and Daufuskie Islands across 23 medical specialties and five disease management clinics for close to 30,000 patient visits annually.
- ▶ 93.4% of VIM's annual expenses are directed to provision of services.
- ▶ From a \$2.2 million annual budget, VIM provides over \$12 million in healthcare, representing an ROI of 6 for every dollar raised.
- ▶ VIM conservatively saves the local hospital, and in turn the community at large, \$2.5 million in uncompensated Emergency Room visits.
- ▶ More than 70% of VIM patients are employed, many within the hospitality and tourism industries. VIM patients are the "working poor" from HHI and the surrounding areas with little or no access to affordable healthcare – except for VIM.
- ▶ VIM is served by more than 600 volunteers who annually give over 52,000 hours of service to ensure VIM achieves its mission.




